CLUB PERMIT SCHEME

ABCCC is a VicRoads authorised Club to participate in the VicRoads Club Permit Scheme (CPS)

The ABCCC has set rules & conditions for operating a motor vehicle [twenty-five (25) years old and older on the CPS, for further information about how the CPS is conducted by the All British Classics Car Club please visit the club's Website Link <u>ABCCC Club Permit Scheme information</u> All the information is available online.

- 1. **Initial contact** should be made with the club's Vehicle Logbook Club Permit Scheme (VLCPS) Applications Officer, currently Wally Thompson. He will advise the procedure for application with respect to the conditions set by the ABCCC. He must also provide a first inspection of the vehicle.
- 2. **PERMIT RENEWALS** VicRoads requires that an ABCCC authorised VLCPS Officer's signature is entered on the permit renewal notice. Therefore, your VLCPS renewal should be sent to Colin Brown, PO Box 40, Coldstream, Victoria 3770. Enclose with it a stamped envelope addressed to VicRoads, along with a cheque/money order for the VLCPS fee. Colin will sign on behalf of the ABCCC, and then forward the permit renewal on to VicRoads. The form also requires YOUR signature, so be sure to sign it as the permit holder as well.

Both Wally & Colin's position are entirely voluntary, so due consideration should be given when contacting them.

Another "lockdown" and time to jot down a few memories. Here's a few lines recalling the first of our MG Y Type collection over the years (6 to date), they've been a great source of pleasure over many years.

"Y" I Luv "Ys"

Geraldine was teaching with Betty Hull when she mentioned that her husband, Kingsley, was going to sell their Y-Type sedan. On seeing it and the condition it had been kept in, we knew it was meant to be. The 'Y' joined the 'B' in the garage, it having been argued that we really did need a second car for "convenience" and that it wasn't really just another expensive toy. The Y-Type did in fact function as the second car and became the



basis of what was to become a Y-Type collection.

Touring in the Y-Type was great fun but probably one of the most enjoyable times was travelling the Great Ocean Road and through the Otways with childhood friend Gavin and Iris, his wife, in their MG-B powered 'Y'. Modern cars would be right behind us on the flat but through the hills, much to their frustration, the two little MGs just walked away from them all and the burble from the exhausts on over-run - was just magic.

On the way home we decided to stop in at Barwon Park near Winchelsea and as we stepped



out of the car we noticed coolant pooling under the front end.

Two of the welch plugs had decided just to "fall out" as we came to a stop. With nothing to be done there, Gavin decided he could tow us back to Geelong with the MGB powered Y. The only problem being he only had about 12 feet of rope in the boot. In typical fashion, he was off like the proverbial "cut cat" with me hanging on for dear life just 10 feet or so from his back bumper bar. Coming into

Geelong saw the funniest incident of the whole trip. A dear old gentleman was cruising along in his early Holden when this dark blue MG Y went passed him at 50 mph and what

must have seemed like a dark green Y Type right on its tail obviously trying to pass it. The look on the old gentleman's face as we sailed by is still etched in my memory – priceless.

The car was used regularly for many years but then for about sixteen years sat on blocks, awaiting the full restoration its originality so richly deserved. Recently it has again seen the light of day with an engine rebuild and a new paint job reflecting the original colour it left the factory with in 1948.

My great friend Lindsay Head of the famous "racing Head brothers" helped me rebuild it and taught me much about its fine features.






It has been fun recalling the good times that we had with our Y Types, thanks Christopher.



Next year on June 22nd planning is underway for a world wide celebration for the 75th. anniversary of the "Y Type". This will be Australia's big gathering in Gympie Queensland although each State will be putting on smaller gatherings Geraldine & I hope to have our four along with fellow member, Clive Dickinson's collection ready for display on that day. Of the 6 and a bit thousand built, there are, according to the International MG Y Register, still 3,500 or so still viable. This is unprecedented in any auto production run of any vehicle



A bit of an interesting read on MG Y type


Quaint pre-war designed MG saloon that shares a lot of DNA with the T Series and almost as much fun although parts supply isn't so nearly as comprehensive. Good value and appreciating quite notably

The "Y" was the first of MG's cars with independent front suspension, rack and pinion steering and many other modern innovations which formed the basis of their sports cars and sports sedans till the end of MG production.

The Y Type was an exceptional small sports sedan in its day with 3529 of the approximate 6100 YAs made still listed as viable examples by the International Y Type Register. Of the very rare MG YT, only 235 or so are on the register. This is unprecedented for any production run of any vehicle anywhere in the world to have almost half of all examples of the marque still viable after 75 years.

The MG One and a Quarter Litre (Series 'Y') model range was produced from 1947 to 1953 and comprised three models: the <u>MG Y</u> (1947 - 1951) - a four door, four seat, six window saloon later called the MG YA after the introduction of the mechanically updated MG YB, in 1951; the <u>MG YT</u> (1948 - 1950) - a two door four seat convertible; and the <u>MG YB</u> (1951 - 1953) - the updated version of the MG Y.

When production ceased, 8,336 "Y" Types had been produced, 6,131 of which were "YA" saloons, 904 were "YT" Tourers (877 is most quoted number) and 1,301 were "YB" saloons.

On 30 September 2021, the Road Safety (Vehicles) Interim Regulations 2020 will be replaced by the Road Safety (Vehicles) Regulations 2021.

The new Regulations have been developed following extensive consultation with industry and community groups, including Club Permit Scheme associations, clubs and members.

The new Regulations include changes to the Club Permit Scheme and the introduction of new offences.

What changes are proposed to the Club Permit Scheme as part of the draft Regulations?

There are several regulatory reform proposals for the Club Permit Scheme aimed at further reducing red-tape and better aligning the scheme with the broader registration scheme. These changes include:

1. A range of new offences

The draft Regulations propose the introduction of specific offences. The proposed new offences relate to a range of items such as compliance with general conditions, failure to complete log book entries and failing to provide a vehicle for inspection.

2. An increase to eligible vehicle age

An increase in the age of vehicles in the Club Permit Scheme is proposed from 25 years to 30 years. This will go further to support the intent of the scheme and will align requirements in Victoria with that of some other jurisdictions.

3. Inclusion of a definition in relation to replica vehicles

The proposed inclusion of a definition for replica vehicles seeks to preserve the integrity of the club permit scheme and provide stakeholders greater clarity as to vehicles which are eligible.

Road Safety (Vehicles) Regulations 2021 (extract VICROADS)

Learn more about the changes to the Road Safety (Vehicles) Regulations.

The Road Safety (Vehicle) Interim Regulations 2020 have expired and a new set of regulations commenced on 30 September 2021. The new regulations are the <u>Road Safety (Vehicles)</u> Regulations 2021(External link).

These regulations are in place for a period of 10 years. They are largely the same as the existing vehicle regulations, but important changes are highlighted here. These reforms are the result of a public consultation process.

The following is an overview of the changes that commenced on 30 September 2021.

Club Permit Scheme changes

Logbook offences

Club Permit holders must ensure that:

- a Club Permit is affixed inside a club logbook
- on each day a vehicle operated under the Club Permit is driven outside the vehicle's local zone, you must ensure that the next available entry in the club logbook is completed before beginning the journey
- if a journey begins before midnight and continues into the next day, an entry must be made in the club logbook in respect of each of those days
- you must not complete or partially complete entries in a club logbook which relate to a future day
- you must ensure that, if a club permit is a 45-day Club Permit, only the first 45 entries in the club logbook are used, unless a second 45-day club permit is issued for the Club Permit period and affixed inside the club logbook
- you must ensure that, if all available entries in a club logbook have been completed, or the Club Permit has expired or been cancelled, the vehicle must not be driven outside the vehicle's local zone until a new Club Permit is issued.

Club Permit holders must not cause or permit a driver of a vehicle operated under the Club Permit to fail to comply with these obligations.

Penalties apply for logbook offences.

It is now an offence to use a Club Permit vehicle as a commercial passenger service

There are now financial penalties to operate a Club Permit vehicle for hire or reward for the carriage of goods or freight, or to provide a commercial passenger vehicle service as defined by the *Commercial Passenger Vehicle Industry Act 2017*.

Operating conditions

In addition to the general conditions, VicRoads may impose an operating condition on a Club Permit that specifies the permissible use of the vehicle operating under that Club Permit.

VicRoads may suspend a Club Permit if it is reasonably suspected that the Club Permit holder has failed to comply with any operating condition of the Club Permit specified in the certificate of approved operations. Internal review rights apply.

Cancellation of a Club Permit

VicRoads may cancel a Club Permit if the payment of a relevant fee and the appropriate transport accident charge is dishonoured or not paid within 3 months after the date of expiry of the Club Permit.

Surrender of a Club Permit


A Club Permit holder may surrender a Club Permit. When doing so, you must ensure that at the time the Club Permit is surrendered, the Club Permit, the Club Permit label and the vehicle's club logbook are removed from the vehicle and destroyed. If VicRoads requires it, you must return the Club Permit number plates to VicRoads. Penalties apply.

Definition of a replica vehicle

The Regulations now define a replica vehicle. 'Replica' means a light motor vehicle that is an individually constructed vehicle that resembles, as close as practicable, the appearance and dimensions of the production vehicle on which its design is based. To be eligible for the Club Permit Scheme, replica vehicles must have the appearance and dimensions of a vehicle manufactured more than 25 years ago.

For a replica vehicle to be eligible for inclusion in the Club Permit Scheme, it must meet this definition, and a VASS approval certificate must be provided with the Club Permit application. Individually constructed vehicles and production vehicles are defined in the Vehicle Standards Bulletin (VSB) 14.





MEMBERSHIP RENEWALS ARE DUE AS OF JANUARY 1ST EACH YEAR

ANNUAL SUBSCRIPTION IS \$45.00 PER FAMILY MEMBERSHIP

All members with cars on the Victorian Club Permit Scheme are required to attend three club events from the date of the motor cars permit issue, and renew their membership by the due date. Failure to do this; they will have their membership cancelled.

The ROAD SAFETY ACT says that you MUST be a financial club member at all times, or your Club Permit plates are invalid and you will be un-insured and ineligible for road use.
